# 0516.04 MINUTES OF MEETING of 6th April 2016

# 0516.05 REPORTS

Cllr Hazell has investigated the issue with the hedge in Pound Road and feels that it is not a problem as long as the cars pull right up to the junction.

Cllr J Prestage reported that the process has started for the parking restrictions in Grenfell Road. The Highways Department have provisionally agreed 2 sets of speed bumps and a raised platform crossing for Owls End and plans will be available for the June meeting. They are also considering resurfacing the road while the work is being carried out as there is a lot of puddling.

#### 0516.07 CEMETERY

The bench in memory of the Late Mr Lague has been ordered. Mr Badcock has asked if some topsoil could be purchased to level out the ground around the graves. This was agreed and Cllr Wakefield would arrange. In order to help with the soil in future it was decided to contact the funeral directors and ask if the grave diggers could fill in the graves with the bottom clay soil and leave the topsoil for filling later. The clearing of old plastic flowers from the cemetery would be carried out by Cllr Johnston.

### 0516.08 FOOTPATHS

The damaged sign on the High Street has been reported – reference no. NM-113640.

As Cllr Scantlebury is unable to produce his bi-monthly footpath reports at the moment all Councillors were asked to report any problems they notice when they are out and about in the village.

It was reported that the flashing speed camera was being obscured by branches. The Clerk is to write to the home owner and ask for them to be trimmed.

# 0516.09 PLAYING FIELDS

A complaint has been received from residents in Brookfield Way with reference to the increased noise being created by the youths on the zip wire now the weather has improved. After much discussion it was decided that the only practical way to deal with the problem was to provide an area specifically for the older children on the large playing field away from residential properties. Ideas to be investigated include a MUGA, outdoor gym equipment and a chat room. Mr Rignall reported that the goal post behind the village hall has rotted and that due to the football team not using the field any longer there is a field marker available if needed.

Letters with details of the circus visit have been distributed to residents of Brookfield Way and Owls End.

Bury Village Neighbourhood Plan Forum

Parish Council Update 4 May 2016

The Forum has now had three meetings and we number nine members.

We have started on the Community Engagement process and are collating lists of people that we need to communicate with such as local businesses and we have started to consider ways that we can get in front of the community to hear their thoughts and ideas.

Part of this might be a number of us walking in the Ramsey carnival with a banner and then a stall at the carnival where we can talk to people. We are thinking of having past and present photos of Bury as part of this.

We have a report published in both the Ramsey Informer and Ramsey and Warboys Reporter and the Informer has offered us a monthly column which we will take up.

The Budget and Project plan will be built up over the next few weeks prior to making an application for funding but we don't want to put this in too early as it must be spent within 6 months so we need to be cautious.

Next steps will be the continuation of contact collection and the drafting of letters, planning our talks to clubs and groups, and of course, talking to people !
