0716.01 APOLOGIES

Apologies were received from Cllr. Hayes

0716.02 COUNCILLORS INTERESTS

0716.03 PARISH COUNCIL VACANCIES

Due to the resignation of two Councillors Mr Tew and Mr Brindley were co-opted on to the council.

0716.04 ELECTION OF VICE CHAIRMAN

The election of Vice Chairman was deferred to the next meeting.

0716.05 MINUTES OF MEETING of 1<sup>st</sup> June 2016

The minutes of the above meeting were approved.

0716.06 POLICE REPORT

Heavy plant equipment has been stolen from a construction compound on the disused airfield behind Upwood Road.

The police are continuing to be called out to incidents at the RAF Upwood site. As the site is also partly in Upwood and Ramsey it was decided to write to the Parish/Town Councils asking for their backing in contacting Strawsons asking them to secure the site to try to prevent the on-going problem.

0716.07 REPORTS

Cllr Hazell reported that he had attended the AGM of the Bury Residents Charity and It has been agreed to install WiFi in the Village Hall.

Cllr Hazell also reported that a letter has been sent to Ramsey Town Council requesting some of the Solar Farm grant money they received. No reply has been received yet.

0716.08 PLANNING

0716.09 CEMETERY

The interment of the ashes of Mr Derrick Pope took place on Friday 1<sup>st</sup> July.

A member of the public asked if the small hedge that was removed around the garden of rest in the closed church yard could be re-instated in some form.

Councillors would have a look and discuss the options with the cemetery gardener.

0716.10 FOOTPATHS

Cllr Scantlebury has produced his bi-monthly footpath report. We have received some complaints about the state of the footpaths, this was due mostly to the weather which has meant that Cambridgeshire County Council are 3 weeks behind with their cutting program. The footpath between Owls End and the playing field is in hand.

0716.11 PLAYING FIELDS

Cllr Hayes has been locking the zip wire over night for a month and the residents have noticed an improvement in the noise levels. It was decided that the trial should continue for another month with a rota for the task of locking and unlocking. The plans for the MUGA/Gym equipment was discussed. It was agreed that we should apply for grants from the Wind Farm and other sources towards the cost and that further information should be obtained from Proludic and perhaps a representative from the company could attend the next meeting to give a presentation.

0716.12 NEIGHBOURHOOD PLAN

Cllr Hazell reported that a committee has now been formed with Jeremy Mumford as the Chairman and that they meet fortnightly. The website is up and running and has a forum for ideas from villagers. The committee are to be present at the Ramsey carnival to advertise the project. The committee also highlighted their concerns over the problems at the RAF Upwood site.

0716.13 TRAFFIC CALMING MEASURES ON OWLS END

Following discussions with local residents and confirmation that the speed bumps will not be a problem for vehicles and that the road will be resurfaced while the work is being carried out, the proposed plans for traffic calming in Owls End were agreed unanimously.

0716.14 PARKING RESTRICTIONS ON GRENFELL ROAD

The County Council have informed us that they have received an objection to the proposed parking restrictions on Grenfell Road. We will know the outcome of their investigations after 15<sup>th</sup> July.

0716.15 SPEEDWATCH

It was agreed to spend £800.00 for the purchase of Speedwatch equipment in conjunction with Wistow and Upwood. The equipment has been purchased by Wistow Parish Council and is to be stored in Wistow Village Hall. The Speedwatch Co-ordinator reported that the roads have been risk assessed and they just need to get the team together and make a start.

#### 0716.20 PUBLIC DISCUSSION PERIOD

Mrs Day commented on how good the circus was and how little disruption was caused and asked if they could come again. The Council agreed.

Mrs McCormick brought up the subject of the money from the closure of the Bury Bugle, which was given to the council 2 years ago by a member of the committee to be used for the provision of outdoor equipment on the playing field. The council explained that the project is still on-going and further discussions are required with the villagers, the various groups that will use the area and the company providing the equipment. Grants are also to be sought. This will all take time and as it is a considerable amount of money it has to be spent wisely. Once all this has taken place the money from the Bury Bugle will go towards the cost. The Chairman will send a letter of thanks to Mrs McCormick.
